

## **OFAH Membership Outdoor Prize Draw – Official Contest Rules**

### **1. Contest Period**

The OFAH Outdoor Prize Draw (the “Contest”) begins at 12:01 a.m. eastern standard time on August 12, 2025 and ends at 11:59 p.m. eastern standard time January 11, 2026 on (the “Contest Period”).

### **2. Eligibility**

The Contest is open to residents of Ontario who have reached the age of majority (18 years or older) at the time of entry. Individuals who purchase an OFAH membership during the Contest Period are eligible to enter. Employees, directors, officers, and contractors of OFAH Membership, as well as immediate family members (defined as spouses, parents, children, and siblings) or persons living in the same household, are not eligible to win. Not available to residents of Quebec. Entries containing false, incomplete, or misleading information will be removed.

### **3. How to Enter**

Eligible individuals are automatically entered into the Contest when they purchase an OFAH membership during the Contest Period. **No purchase necessary:** To enter without a purchase, eligible individuals may send a written request along with their full name, mailing address, phone number, and email address to:

Requests must be received no later than 11:59 p.m. eastern standard time on January 11, 2026. Entries submitted without a purchase will have the same odds of winning as those obtained by purchasing a membership.

### **4. Bonus Entries**

In addition to their initial entry, OFAH members can earn bonus entries into the prize draw in the following ways during the Contest Period:

**Auto-Renewal Bonus** – Members who opt into the Auto-renewal program during the Contest Period will receive one (1) bonus entry into the prize draw. Auto-renewal enrollment must be completed and confirmed within the Contest Period to qualify.

**Referral Bonus** – Members who refer new or returning members during the Contest Period will receive one (1) bonus entry for one (1) referral, five (5) bonus entries for two (2) referrals, and ten (10) bonus entries for three (3) or more referrals. Referrals must include

the referring member's OFAH Member ID or full name and email address at the time of sign-up. *"Returning member" means an individual whose OFAH membership has lapsed prior to or during the Contest Period. "New member" means an individual who has never held an OFAH membership. Self-referrals are not permitted.*

The OFAH reserves the right to verify Auto-renewal status and referral eligibility before awarding any bonus entries.

## **5. Prizes**

Prizes will be awarded as follows (approximate retail value in CAD):

- Lund WC-12 boat with Mercury 9.9HP outboard and trailer – \$11,970
- Mercury 9.9HP outboard – \$3,540
- Fly-in fishing trip for two to Kesagami Lodge – \$5,900
- Spring bear hunt for two with Olive the Lake – \$4,200
- Spring bear hunt for two with Maiden Bay Camp – \$5,800

Prizes are non-transferable and must be accepted as awarded. No cash substitution is available. Travel, gratuities, licensing, permits, taxes, and other costs not expressly covered by the prize are the responsibility of the winner.

The OFAH reserves the right to substitute any prize with one of equal or greater value if the stated prize becomes unavailable for any reason. Entrants may win only one (1) prize; once selected as a winner, their name will be removed from subsequent prize draws.

## **6. Winner Selection**

Winners will be selected by random draw conducted electronically on January 12, 2026 at 10 a.m. eastern standard time. Winners will be contacted by phone or email within 5 business days of the draw. If a selected entrant cannot be reached within 10 days, fails to respond, or does not meet the contest eligibility requirements, another entrant will be selected. If a prize remains unclaimed 30 days after winner notification, the prize will be forfeited, and another eligible entrant will be selected by random draw.

Before being declared a winner, each selected entrant must correctly answer a mathematical skill-testing question and may be required to sign a Declaration of Eligibility and Liability/Publicity Release. Winners also consent to the use of their name, city of residence, photograph, and likeness for publicity purposes without additional compensation, unless prohibited by law.

**7. Odds of Winning**

Odds depend on the number of eligible entries received during the Contest Period.

**8. Limitation of Liability**

By entering, all participants release and hold harmless the OFAH, contest sponsors, partners, and affiliates from any liability, loss, or damage arising from or in connection with participation in this Contest or the awarding, receipt, possession, and/or use or misuse of any prize.

**9. Privacy**

Personal information collected for this Contest will only be used to administer the Contest and will be handled in accordance with the OFAH Privacy Policy available at <https://www.ofah.org/privacy-policy>.

**10. General Conditions**

The OFAH reserves the right to cancel or modify the Contest at any time for any reason without notice, verify the eligibility of any entry, and disqualify any individual found to be tampering with the entry process or violating these rules. This Contest is subject to all applicable federal, provincial, and municipal laws and regulations.
